LIFE SAVINGS PHASE-OUT NOTICE

After careful consideration of all the factors involved, we must revise our Life Savings Insurance, which is underwritten by CMFG Life Insurance Company and provided by the Credit Union at no direct cost to you. New deposits will no longer be eligible for Life Savings Insurance starting on June 1, 2013.

IMPORTANT: This change does not affect your existing Life Savings Insurance coverage on eligible deposits made before June 1, 2013. These deposits will remain eligible until the original deposits are withdrawn or the policy canceled. You will want to keep in mind that because the Life Savings Insurance group policy is offered at the discretion of the Credit Union, it should not be regarded as permanent insurance.

Any CUNA Mutual Life Savings Certificate of Insurance you may have is valid only for eligible deposits made prior to June 1, 2013. The maximum total balance eligible for Life Savings Insurance is \$2,000 per member.
