Call for Nominations!

The 2016 Nominating Committee is taking applications for candidates for the OKFCU Board of Directors. The credit union's directors are volunteers, receiving no compensation for their service. They have the fiduciary responsibility to provide general direction and control of the credit union. Time requirements include monthly meetings, ongoing educational sessions, and other activities. The qualifications to be a member of the Board of Directors are:

1. Must be over the age of 18.
2. Must be a member in good standing of Oklahoma Federal Credit Union.
3. Cannot be a paid employee of the Credit Union.
4. Cannot have any immediate family members who are paid employees of the Credit Union.
5. Must be willing to serve a three year term.

7. Must be able to attend monthly meetings and an annual planning conference.

8. Maintain the highest level of ethics and confidentiality in all Board of Director dealings.

Nominations must include the following information:

1. Letter of nomination/introduction.
2. A current resume.

All nominations should be submitted no later than November 30, 2016; Nominations will not be accepted after this date.

The Nominating Committee will notify individuals of their eligibility of nomination, seventy-five (75) days prior to the Annual Meeting.

EMV OKFCU Check (Debit) Card

Oklahoma Federal Credit Union (OKFCU) is pleased to announce exciting changes to your OKFCU Debit Visa Card! In mid-September you should receive a new OKFCU Check (Debit) Visa Card in the mail. This new card will replace your existing Debit Visa Card. You activate your new card before using it for purchases, just follow the instructions that will appear on the front of the card.

Please be sure to destroy your old card at that time as it will be deactivated on that date. For your convenience, your Personal Identification Number (PIN) will remain the same PIN you are currently using with your existing card.

Starting in September, OKFCU Debit Visa Cards will come with built-in chip technology. These new cards are more secure and they're also easy to use.

In addition you have enhanced security, when you use your card at a chip-activated terminal. The embedded chip generates a one-time use code, this code is virtually impossible to counterfeit and helps reduce in-store fraud.

If a chip-activated terminal is available, follow these easy steps:

1. Insert the chip end of your card into the terminal with the chip facing up.
2. Keep your card in the terminal throughout the transaction and follow the prompts on screen.
3. Remove your card when prompted and take your receipt.

More merchants are accepting chip transactions every day. Chip-activated terminals are coming to certain U.S. retailers this year – and more locations in the years to come. If a merchant cannot accept chip transactions, simply swipe your card to pay.

IMPORTANT: If you have used your existing OKFCU Debit Visa Card to pay for services that are billed directly to your card, such as Internet services, insurance, gym fees, etc., be sure to contact these vendors and provide your new card number as soon as you receive it so that your service is not interrupted.

Also remember if you plan on being out of the state or country and plan on using your OKFCU Visa Debit Card, please call before you travel. We can put a travel notice on your account for the period of time you will be away from home, so your OKFCU Visa Debit card will not be blocked.
