To Oklahoma City Federal Credit Union:

Please be informed that as of December 2, 2017, the Oklahoma City Veterans Affairs Health Care System is terminating the Revocable License agreement (attached) between the Oklahoma City Federal Credit Union and the Federal Government. This includes approval to occupy physical space within all Oklahoma City Veterans Health Care System for in person banking services. This decision has been made to increase availability of facility space for Veterans' health care services and work areas for our employees to serve Veterans.

Automated Teller Machines (ATMs) will be allowed to remain as currently positioned within the medical center until further notice. Occupancy and approved access to the facility by Oklahoma City Federal Credit Union employees or leadership for any reason beside ATM maintenance and/or official government business will not be allowed beyond December 1, 2017.
