+ Call for Nominations

The 2023 Nominating Committee is taking applications for candidates for two (2) positions for the OKFCU Board of Directors. The qualifications to be a member of the Board of Directors are:

1. Must be over the age of 18.
2. Must be a member of Oklahoma Federal Credit Union and be in good standing.
3. Cannot be a paid employee of the Credit Union.
4. Cannot have any immediate family members who are paid employees of the Credit Union.
5. Must be willing to serve a three-year term.
6. Must be able to attend monthly meetings and an annual planning conference.
7. Maintain the highest level of ethics and confidentiality in all Board of Director dealings.

+ Net Branch is Changing to Virtual Branch

An upgraded remote access to your account is coming in October 2023. This upgrade provides improved alignment between the online mobile app systems for a more user-friendly experience. This upgrade includes a more secure multi-character Login ID and Password/Security Code to protect you and safeguard your accounts. Your account number will no longer be your Login ID. If you are currently using your account number as your Login ID, we encourage you to update that prior to the upgrade. For example, some multi-character options might include: B987654r, Daisy1972, B3L13V3Me and so on. These expanded options allow you to choose a Login ID that is easy for you to remember. The holidays are quickly approaching which means Skip A Pay will again be available for November 2023. If you are a member in good standing and would like to skip your Consumer loan payment for November, just complete the form below and return to the Credit Union. The processing fee is only \$30 per loan and can be withdrawn from your Oklahoma Federal account or can be sent in with the completed form. If your loan payment is made automatically such as payroll deduction or ACH, please return the form no later than October 20, 2023 to allow us time to make the necessary change. If you pay your payment manually, please have the form returned at least one week before the due date. If the form is not returned by the due date, or the fee is not paid, your request will not be honored.
